## **Description of the problem, Background & General Information:**

It is not certain when the United Nations Peacekeepers – also referred to as the UN "blue helmets" – started violating the victims in the countries they were aiding, but some UN-officers have been abusing their power when on peacekeeping missions. It has long been implied that some of the UN personnel on these peacekeeping missions are actually helping with the enslaving and prostitution of – especially – women and children in the nations they work in.

The UN Blue Helmets have had personnel accused of abusing civilians in countries where they are supposed to help, however, no personnel has ever been convicted of the crime they were accused of, either because what the "blue helmet" has done is in accordance with the laws of his/her own country or because there haven't been sufficient material available to convict the accused.

The problem of UN personnel abusing civilians is ever growing, the uncertainty that arises with this severe issue affects the countries where the UN Peacekeepers are involved, the population of the country will then no longer feel safe once the UN Peacekeepers move into the country in order to help, the citizens will then live in fear of possibly being abused or used in any way by the people placed there to protect them.
